Sliding Fee Scale

To qualify for the Sliding Fee Scale, you must bring in to the Health Center proof of your income and a social security card for the heads-of-household and all dependent children up to 18 years of age. Upon approval you will also be eligible to receive your dental services on the Sliding Fee, however, the minimum fee for dental is different than the fee for medical. Please contact the CDHC Dental Program at (402) 453-1433 to determine what your fee would be for dental services.

All fees are due at the time of your visit. If you are not able to pay your fee at the time of your medical visit, you will need to speak with a CDHC staff person to make arrangements for payment. If you are unable to pay your fee at the time of your dental visit, you will be asked reschedule your appointment for a later date.
