



Director Houston was appointed to this position by Governor Dave Heineman on March 14, 2005. Immediately preceding his appointment, he was Director of the Douglas County Department of Corrections having served in that position since April 2003. He started his state corrections career in 1974 as a counselor at the Nebraska State Penitentiary. In the years that followed, he held progressively more responsible positions throughout the Agency to include Unit Manager at the Lincoln Correctional Center, Unit Administrator at the Nebraska State Penitentiary, Associate Superintendent at the Omaha Correctional Center, Deputy Warden at the Penitentiary, Warden at three institutions Omaha Correctional Center, Lincoln Correctional Center, and Nebraska Correctional Youth Facility and from September 2002 to April 2003 he served as the Assistant Director of Programs and Community Services. Mr. Houston serves on many boards and committees such as the Jail Standards Board, the Crime Commission, the Community Corrections Council, the Capitol Facilities Planning Committee, and the Interstate Compact for Adult Offender Supervision. He is the Co-Founder and Member of the Omaha's Metropolitan Chief's Association, Board President of the UNO/UNL Criminal Justice Education Fund within the University of Nebraska Foundation, past president of the United State's Deputy Warden's Association and the Nebraska Correctional Association.

Mr. Houston has a Bachelor of Science in Criminal Justice from the University of Nebraska-Omaha and a Master of Science in Criminal Justice from the University of Nebraska.

Director's Forward

I continue to be very proud to be a member of one of the very best correctional systems in the nation, the Nebraska Department of Correctional Services (NDCS). I present to you this 2008 Annual Report. Whether you are a NDCS staff member, researcher, legislator, student or member of the Nebraska community, please be assured that our Department employs the Nation's finest correctional practitioners to meet difficult challenges. Our rich history extends back to 1851 when we served as the Nebraska Territory Prison. Today, we are the State's largest criminal justice agency. NDCS maintains a firm commitment to providing effective protection for our citizens and high quality operations as was recognized in 2007 when our Department received the "Eagle Award". We are now part of the elite group of fifteen prison systems in the nation that are 100% fully accredited by the American Correctional Association.

As our inmate population continues to grow, we respond with careful planning and research to determine future needs. We also attend to the needs of others such as county jails by providing jail management and medication aide training throughout the year. We continue to be engaged in strategic planning with Nebraska Probation to expand community resources while reducing or stemming growth in our inmate population. Our Department is determined to lower the cost of government, while protecting the public. We are fully engaged in exploring front-end, in process and back-end solutions to crowding. During the past thirty months we have realized a two percent decrease in our incarcerated population while our parole count reaches historically high numbers.

In 2006, we dramatically increased the number of inmates at our community correction centers. We lowered inmates' custody levels while increasing protection for the public. This action has increased inmate optimism and decreased tension and future costs. Further, we have had no significant increase in crowding in our facilities with high-risk inmates during the past two and a half years.

By keeping inmates engaged with meaningful and fulfilling jobs, programs and activities contribute directly to our level of safety, security and order. The hard work and effort by Departmental staff assigned to Cornhusker State Industries (CSI) has increased the number of inmates employed by Industries. Programming staff contribute by preparing outstanding volunteers to serve a unique role in support of inmates and the Department. NDCS has implemented and will continue to expand re-entry activities. By September of 2009 we will have doubled the size of our residential treatment for substance abuse. In October, 2008 we opened our new Mental Health unit at the Lincoln Correctional Center. We continue to grow the number of manufacturing jobs by adding industry space in our facilities.

Our Strategic Master Plan provides a plan for the Agency's future needs. Our plan is designed to only seek facility increases when, after alternatives are exhausted, capacity increase becomes necessary. In 2007/2008 our Health Services Division, with assistance from the National Institute of Corrections, redesigned our delivery of services by concentrating on high-risk and mentally ill inmates.

I am very pleased that you are taking the time to study this aspect of our Department's challenges and accomplishments. Please call me at 402/479-5710 if I can assist in any way.



We make all appointments, promotions and dismissals in accordance with rules, laws, and merit, rather than the furtherance of personal interest or favoritism.



The Legal Division supports all Department of Correctional Services programs and institutions by giving legal advice and representation regarding labor relations, inmate rights, contracts, legislative issues, Inmate grievances, transportation orders, or matters involving litigation and the Courts. Legal Division staff work with the Courts, the Nebraska Department of Justice, attorneys, arbitrators, State Senators, the State Claims Board, the Office of Public Counsel, other State Agency officials, and the general public.

A. DESCRIPTION OF ACTIVITIES

Health Services are provided at the Nebraska Department of Correctional Services (NDCS) adult facilities for all inmates under the jurisdiction of NDCS. The mission of Health Services is to ensure that all inmates receive services designed to maintain good health. This is accomplished by providing a wide range of health services including mental health and substance abuse services. Due to the nature of the health care delivery system, medical staff provides inpatient and outpatient services through an integrated medical, mental health, psychiatry and substance abuse team approach.

The NDCS has three hospitals located at the following institutions: Nebraska State Penitentiary – twelve (12) beds; Diagnostic and Evaluation Center – eight (8) beds and the Tecumseh State Correctional Institution (TSCI) – ten (10) beds. In addition, the NDCS has medical clinics located at the following institutions: Nebraska State Penitentiary (NSP), Diagnostic & Evaluation Center (DEC), Tecumseh State Correctional Institution (TSCI), Lincoln Correctional Center (LCC), Omaha Correctional Center (OCC), Community Correction Center-Omaha (CCC-O), Community Corrections Center-Lincoln (CCC-L), Nebraska Correctional Center for Women (NCCW), Nebraska Correctional Youth Facility (NCYF) and Work Ethic Camp (WEC). All hospitals are licensed by the Department of Health and Human Services and fully comply with all requirements imposed by that department.

Behavioral Health

NDCS Behavioral Health emphasizes treatment services for high risk, high need populations. The primary focus of Behavioral Health is to provide services to inmates with major mental illness. Other priority populations include violent offenders, sex offenders, and substance use disorders. Clinical review teams make specific recommendations for treatment interventions for these core groups.

Mental Health Services:

Mental Health offers a wide range of services and programs to address the mental health needs of high risk offenders with an emphasis on those with major mental illness. The services include assessment and evaluation, residential and outpatient treatment programs, and crisis intervention.

Residential Programs:

The Mental Health Unit (MHU) provides residential treatment services to inmates with major mental illness or severe social/developmental impairment. Program goals include learning about and coping with major mental illness or social deficits and improving coping skills with the goal of transitioning to general population. The length of this program varies depending on needs and progress in treatment.

The Inpatient Healthy Lives Program (IHeLP) provides treatment to inmates who are at the highest risk for sexual re-offense. The program uses materials and assignments in a group therapy setting. This is an intensive 18 to 24 months program, though individual treatment time varies based on the needs and progress in treatment.

Outpatient Treatment Services:

Anger-Violence Programming – Programming is offered to high risk inmates with a history of violence. Programming includes anger management which provides instruction and practice on basic anger control strategies. The violence intervention program focuses on interventions for violent criminal offending and is currently under development. Aggression Replacement Training (ART) is targeted to youthful offenders.

Outpatient Healthy Lives Program (oHeLP) – Treatment is offered to those inmates who are assessed to be at a relatively higher risk to sexually reoffend. Participants in oHeLP work through materials and assignments in group therapy. oHeLP takes about one year to complete.

Bibliotherapy Healthy Lives Program (bHeLP) – Treatment is offered to those inmates assessed to be at low risk to sexually reoffend, relative to other sex offenders. Participants in bHeLP work at their own pace on materials provided by the therapist. bHeLP takes several months to complete.

Continuing Care – Continuing Care is for those individuals who have completed the recommended sex offender treatment program. People in the Continuing Care program work in a group setting with peers and therapists to address treatment needs as they arise.

Psychological Services- Psychological evaluations are completed based on Unit Staff or Parole Board referral.

PREA-Related Services-Mental Health Staff assist with the provision of assessment and treatment services for offenders identified as a high risk for predatory behaviors and offenders who are at risk for victimization.

Other Services- Crisis management services are also available as needed.

Substance Abuse Services:

Substance abuse offers a wide range of treatment services to address the needs of offenders who have substance abuse or substance dependence issues. Services include residential and non-residential treatment and assessment of substance-related problems. Substance abuse is in process of expanding its current residential treatment beds from about 230 to about 400.

NDCS Administrative Support

Residential Programs:

DCS maintains over 230 residential treatment beds at 4 separate facilities. Inmates assigned to these programs have been identified as having serious substance abuse issues. The residential program generally lasts about 10 months. Short-term residential treatment is also offered at one facility.

Non-residential Programs:

This service is available for offenders who are not eligible for the residential program who have lower level substance abuse issues and is available at 3 facilities. The program lasts up to 6 months.

Psychiatric Services:

Psychiatry services are offered to provide pharmacological treatment to inmates with mental illness. All of the institutions are served by a Staff Psychiatrist or consulting psychiatrist who prescribes and manages psychiatric medications.

Additional Behavioral Health Services

Behavioral Health contributes to DCS in several other important ways. First, multiple grants are administered through Behavioral Health. Second, Behavioral Health actively provides numerous trainings for its professional staff. Recent trainings have focused on areas including psychopathology, sex offender assessment and treatment, and substance abuse treatment. Third, Behavioral Health conducts audits at each institution on an annual basis to promote quality improvement.

The PRA manager provides guidelines, oversight, and structure for the planning process through-out the department to ensure consistency with vision points, key initiatives, core values and goals. He provides assistance, as needed, to institutional and program planning processes; and supervision and assistance in the following areas:

RESEARCH

PRA reviews all research designs and proposals, whether internal or external to the agency, to ensure compliance with the agency's goals and objectives, rules and regulations, and the maintenance of privacy rights for participants. A review of the purpose, hypothesis, methodology, and data requirement for all research proposals is conducted to assess the potential impact (benefits, security issues, cost, and staff resources). PRA works closely with universities, students, and independent researchers, to facilitate research within the Agency.

ACCREDITATION

The Department of Correctional Services has been involved in the Accreditation process since 1979. All of the Department state institutions, Central Office, Staff Training Academy and Adult Parole Administration are accredited. After initial accreditation, institutions and programs are audited every three years in an effort to maintain accreditation. Accreditation offers the opportunity to evaluate the Department's operations against national correctional standards, remedy deficiencies, and upgrade the quality of correctional programs and services. Benefits of the accreditation process include improved management and conditions of confinement. Accreditation also increases accountability and enhances public credibility for administrative and line staff. The process provides for a safer and more humane environment for personnel and offenders. This process has assisted the Department by establishing criteria for upgrading programs, personnel and physical plant on a continuing basis.

ACA is revising all existing standards to facilitate performance measures. The move towards performance measures requires a "fundamental shift in thinking" for the field of corrections. Instead of showing standard compliance through activities or practices, a specified condition will need to be measured and achieved. Performance based standards require corrections to embrace the concepts of Continuous Quality Improvement and challenge the traditional ways of thinking and operating.

Performance based standards will not only affirm that the Department is meeting its mission, but provide a measurement of its efforts. Operational effectiveness and efficiencies will be measured over a three-year accreditation /audit period. The measurements will enable the Department to benchmark services and improve the quality of life for staff, inmates and the public. Nebraska Department of Correctional Service is proud to be one of fifteen states that all facilities and programs have achieved accreditation through the American Correctional Association.

During fiscal year 2008, inmate data based applications and reporting have expanded dramatically. PRA now manages 48 applications on the Corrections Website, a web-based application, along with reporting on the Oracle Siebel report writer system.

This year, an automated Misconduct Report and Routing System was implemented, tracking the institutional misconduct reports. From writing, to hearings, through the Wardens approval process, this all electronic MR system will enhance the ability to glean a tremendous amount of data concerning the disciplinary process throughout all of the facilities.

A new visitor tracking system was also put in to place in the facilities, tracking the actual visitors entering the facility and accounting for the number and duration of the visits.

PRA continues to provide information/data to other state and federal agencies, the State Legislature, researchers, national surveys and the DCS management staff.

Drug Testing

The Department's Inmate Random Drug Testing Positive Rate, slightly increased for FY2008. A total of 5923 Facility Random Drug Test were submitted with a positive rate of 1.384%. This compares with 1.27% for FY 2007 and 1.76% for FY2006. NDCS continues to use all drug interdiction tools available to maintain a safe and drug free Department.

The department remains committed to a zero tolerance drug policy.

Criminal Information

In FY2004, the Nebraska Department of Correctional Services was chosen by the National Institute of Justice for a Data Mining Sharing Initiative Project. The goal was to assess, review analytical & presentation software, and review data mining capabilities of intelligence/information data that would assist local and regional law enforcement.

Since then, we have taken various steps to share Intelligence/Information data with local, State, and Federal law enforcement entities. During FY2008, NDCS continued sharing Intelligence/ Information data with these agencies to better serve the State of Nebraska. This is being done by Criminal Analyst working closely with the NDCS investigators, continued networking and communication with law enforcement agencies and the sharing of data through the NIJ Data Mining Sharing Initiative Project. NDCS will continue to provide NDCS Intelligence/Information to the users with the greatest need in a timely manner.

PLANNING, RESEARCH AND ACCREDITATION (PRA) continued..

Performance Based Measurement System

The Department has joined the Association of State Correctional Administrators (ASCA) in supporting the Performance Based Measurement System (PBMS), which systematically collects, manages and shares data across jurisdictions, enabling administrators to identify strengths and weaknesses internally and in comparison with other correctional systems. Its purpose is to develop consistent and meaningful correctional performance measures for adult prisons and community-based programs and to develop an automated system that would enable the collection, management, and sharing of that data – specifically in the areas of Public Safety, Institutional Safety, Mental Health and Substance Abuse, Justice, Academic Education, and Offender Profile/Contextual data.

In late 2005, NDCS joined a smaller but growing group of prisons that are currently inputting information into the system. In 2007, NDCS continues to redevelop our information gathering practices to incorporate current and future PBMS needs. In the near future, ASCA will add new Health Care measures to the PBMS.

The purpose of Organizational Development is to continue to facilitate a Total Quality approach of organizational transformation at the Nebraska Department of Correctional Services by evaluating current policy and practice.

DCS continues to work towards an agency-wide transformation in which we shift how we fundamentally think and work together. To date, several integrated initiatives have been designed and implemented to aid in this transformation.

Continuous Quality Improvement (CQI) CQI is a philosophy and strategy for continuously improving performance at every level of the organization and in all areas of responsibility. CQI is a total systems approach that promotes innovation, leadership, creativity and personal mastery. There are several active Quality Councils in the Department and training efforts are continuous. Courses offered include Quality Awareness, Teams, Tools, and Techniques, Meeting Facilitation, Excelling as a First Time Supervisor, and Correctional Leadership I and Advanced Correctional Leadership courses.

Diversity - This initiative was first identified in 1991 and established in 1992 and has involved extensive work including diversity training, a work environment survey, policy revisions, and awareness efforts. In addition, the Department recognized that its strength and its major resource in achieving goals and objectives is the agency's staff. Human relationships provide the cornerstone of all Departmental efforts. Work continues in recruiting, retaining, and training culturally and ethnically diverse staff.

CSI—WE BUILD OPPORTUNITY

During FY2008, CSI converted to NIS Sales and Manufacturing; completed and opened a Wood Shop at TSCI; added CNC/Edgebander PIECP at LCC along with additional new and expanded existing PIECP operations; made plans for three additional production buildings; began Braille transcription services at NCCW; employed 586 inmates within traditional shops and private venture operations resulting in over 726,913 hours of inmate labor. Private venture contributions returned to the community in the form of state and local taxes, victim reparations, inmate room and board, family support, and release savings topped \$691,000 in FY 2008. CSI also processed over 6.5 million pounds of laundry for tax supported and non-profit end users. The Nebraska Department of Correctional Services is committed to ensuring that compliance to all aspects of the Americans With Disabilities Act is met. The office of the ADA Coordinator responds to all requests for accommodation/s from DCS employees, inmates and the public. It is also responsible for the development, review and revision of Departmental policies and procedures to ensure compliance. This Division is responsible for the Return To Work policy which assists employees injured on or off the job, or who have an illness that affects their ability to perform their job, to return to work in a modified status.

The Victim Assistance Program recently began instructing Victim Impact Classes for offenders at the Nebraska Correctional Youth Facility and the Omaha Correctional Center. The underlying goal of these classes is to help offenders develop empathy - making them more in tune to the humanistic harm caused when a crime is committed; thereby, reducing the likelihood of them committing future crimes inside and outside of the correctional facility. The heart of this program is having them listen and interact with victims who have been harmed by crime.

Services provided include:

- Crisis intervention throughout the corrections process, including assisting victims with concerns related to inmates and parolees under Nebraska's jurisdiction;
- Community education about policies and procedures of the Nebraska Department of Correctional Services;
- Assistance preparing for parole hearings;
- Referrals to other state and local community services;
- Explanation and referral for restitution processing assistance; and
- Face-to-face meetings with the offender through Victim Offender Dialogue.

The Accounting Division has responsibility for all financial and inmate accounting functions for the Department of Correctional services. Additionally, the Accounting Division is responsible for establishing uniform accounting practices and procedures within the Department of Correctional Services consistent with state policy and practice, as well as generally accepted accounting principles. The Accounting Division is responsible for providing fiscal support to all programs and facilities within the Department and has the oversight for internal controls.

Financial Accounting functions include both accounts payable and accounts receivable. This includes payments for all goods and services received by the Department regardless of funding source, including verification that all payments are appropriate through the pre-audit process. Accounts Receivable covers all billings both internal and external to state government, including Cornhusker State Industries, Federal Surplus Property, and county safekeepers. Reports from the Nebraska Information System are generated and made available to the various staff throughout the Department electronically.

Inmate Accounting provides for a system of accounting for all inmate funds through the Inmate Trust Fund and ledgers maintained in the Correctional Information and Tracking system. The functions include processing transactions related to the various accounts (institutional, confiscated, restitution, maintenance, suspense, savings, and legal) held by inmates, processing inmate payroll (both institutional and private venture), and reporting necessary to inmates, courts, and other authorized entities. Inmate Accounting also receipts, tracks and provides reports on parole programming fees.

The Accounting Division is also responsible for all fiscal reporting on grants and preparing various financial statements, including canteens, Cornhusker State Industries, and Federal Surplus Property. Additionally, claims are audited and processed in accordance with the law for the County Jail Reimbursement aid program. Other areas of responsibility include internal fiscal audits, Coordinating external financial audits, coordinating payroll reconciliation and verification, monthly Business Managers' Meetings, and quarterly Canteen Supervisors Meetings.

NDCS Administrative Services

BUDGET

The Budget Management Analyst is responsible for planning, organizing, monitoring and reporting the Department's fiscal allocations and fiscal reporting systems. She also analyzes, manages and reviews the preparation, documentation, implementation and control of program budgets including the biennium and deficit budget processes. Fiscal and accounting data are compiled for use in budget evaluation and adjustment, cost analysis, budget projections and reporting. The area of responsibility also includes the fiscal note process.

ENGINEERING

Doug Hanson, Facilities Engineering Manager 402-479-5742

The engineering division provides the department with technical and facilities management assistance for construction projects of all sizes, from the preliminary planning stage to completion and readiness for occupancy. The engineering division is responsible for the development and implementation of the capital construction budget and deferred repair program for all state correctional facilities.

Facilities engineering works with the correctional administrators in the planning, design, construction and occupancy of new and remodeled facilities.

Engineering provides technical assistance for utility and energy contracts. The engineering staff provides guidance and technical assistance to the various facilities and programs to manage their maintenance programs. Engineering also oversees the maintenance and custodial program (maintenance section) for the central administrative buildings.

The engineering division also has oversight of the safety and sanitation section. The safety and sanitation section is responsible for addressing the safety functions of DCS, provides periodic inspections of all facilities, and provides assistance in the accreditation process. This section works closely with the state fire marshal's office and other regulatory agencies in the resolution of compliance issues involving all DCS facilities.

NDCS Administrative Services

PROCUREMENT

Jan Lehmkuhl, Materiel Administrator 402-479-5714

The Purchasing Section is responsible for procurement of all goods/services, inventory control processes, the operation of the DCS Central Warehouse, the operation of Staff Clothing-Issue, and the coordination of form usage within the Agency. The Materiel Administrator is responsible for the review, coordination and approval of all Purchasing functions of the Agency.

Purchasing actively pursues the acquisition of quality products and services at the most economical cost. This is done in part by assuring the accuracy of specifications, competitive bidding, quality control checks of deliverables, utilizing Department of Administrative Services (DAS) commodity contracts, coordinating shared contracts with other State agencies as appropriate, monitoring vendor and contractor performance and by utilizing Cornhusker State Industries as a preferred Agency source. DCS Purchasing staff is responsible for ensuring products and services are delivered timely and received as ordered. They interact with facility and program staff to assure end-user needs are being met, to address procurement and/or receiving issues and to coordinate completion of Agency service contracts.

Inventory responsibilities include the tracking of all Fixed Assets within the Nebraska Information System (NIS) and the formulation of standardized supply inventory practices throughout the Agency. Inventory actions involving DCS owned property is monitored and annual reports regarding DCS Fixed Assets are submitted to DAS as appropriate. The DCS Materiel Control Manager is responsible for coordinating the motor vehicle needs of all DCS facilities and programs. This includes monitoring vehicle mileage logs, coordinating movement of vehicles within the Agency, coordinating vehicle repairs, appropriate processing of accident reports and coordination of vehicle purchases/leases.

The DCS Central Warehouse services all Lincoln facilities. The operation has a dual purpose – to fill facility and program requisitions from stock for standard, frequently used products and to receive all deliveries from outside vendors for each of the DCS Lincoln locations.

All staff uniforms are issued and tracked through the centralized Clothing Issue operation. Clothing Issue is responsible for both the initial issue to new hires and replacements to existing staff.

HUMAN RESOURCES

Marian Layman, Human Resources and Development Administrator 402-479-5752

The Human Resources Section is responsible for providing all aspects of human resources management for the Department of Correctional Services. This includes just almost 2400 full time employees working in 186 different job classifications. The Human Resources Section oversees administration of three different sets of employee work rules: two Labor Contracts; one with the Nebraska Association of Public Employees and the second with the State Code Teachers Association; and for all other employees, the Nebraska Classified System Rules and Regulations.

The Human Resources Section also administers the following areas: labor relations, tuition assistance, recruitment and retention, human resource strategic planning, conflict resolution, discipline, classification and compensation, employee assistance program, affirmative action, payroll and benefits, Agency Personnel Almanac, Human Resources Information System, Employee Physical Exam process, criminal records checks, pre-employment, random drug testing, correctional officer testing, and paid internship program.

SAFETY/SANITATION

This section is responsible to provide a secure and safe environment for both staff and inmates to realize individual potential. The safety and sanitation functions are accomplished through inspections of all facilities on a periodic basis. Administrative Regulations are developed and revised in order to comply with American Correctional Association (ACA) standards and other state and federal statutes, codes and regulations, Occupational Safety and Health Administration (OSHA) regulations, the National Electrical Code (NEC), and National Fire Protection Association (NFPA) standards. The Safety Coordinator conducts bi-annual Safety Awareness Training for employees, which covers all of the above mentions regulatory agencies. The Safety Coordinator is a regular member of the DCS internal auditing team and has responsibility for the Department's asbestos abatement program and environmental monitoring program.

INFORMATION SYSTEMS

George Wells, Information Services Manager 402-479-5658

The Information Systems (IS) Department is responsible for providing computer support to all NDCS staff, Cornhusker State Industries (CSI), and the staff and members of the Nebraska State Board of Parole. There are approximately 1300 computers and 50 servers dispersed to 20 different sites. The NDCS network supports the use of this equipment and provides a pathway for accessing the State's Mainframe computer, the Nebraska Information System (NIS), the state's centralized email system, the Seibel server, and several other systems managed by other State of Nebraska Agencies. The NDCS network also supports remote access and management of various building automation and security systems as well as inmate used systems in the CSI shops and inmate Law Libraries.

The IS Department provides administration and management of the NDCS network and provides assistance to all NDCS staff in the determination of technical specifications to meet the needs of new application software, systems, or changes in functional requirements. Responsibilities of the Information Systems department include the installation, repair, ordering and replacement computer systems and peripherals as well as the development and support of database applications for internal use and keeping a current inventory of computer equipment and software.

GRANTS ADMINISTRATION

The Federal Aid Administrator III is responsible for coordinating and managing all aspects of the department's grant activities from federal, state, and other funding sources to support worthy and qualifying projects. She is also responsible for providing technical assistance to agency staff on all grant activities including preparation, application, monitoring, and reporting.

Additionally, the Grants Administration section is responsible for reviewing and responding to all sub-grantee applications and inquiries as well as conducting program audits to ensure activities are carried out in a responsible and consistent manner as per grant guidelines. SECURITY LEVELS

COMMUNITY A AND COMMUNITY B

The Department's community correction facilities in Lincoln and Omaha are designed to provide the initial step that many offenders take in returning to Nebraska's communities. This is accomplished through a graduated release and a systematic decrease in supervision and corresponding increase in responsibility. Inmates nearing release on parole or discharge from sentence are eligible through a classification system to be promoted to community custody status. Inmates on Community A are assigned to a detail within the facility, assignments within other state agencies, or work assignment in the community. Community A inmates are furnished clothes, room and board and a daily wage. Community B inmates participate in the work and education release program. Inmates on work release are employed in the community, receive competitive wages and pay applicable taxes. Inmates on educational release attend local vocational, technical, business colleges and universities. Community B inmates are responsible for their own clothing and personal items and pay room and board costs of \$10.00 per day.

Programs: Work detail, work release, educational release, furloughs, ABE/GED, and substance abuse programming; community activities passes (e.g. recreation, shopping, religious) and other programming (family counseling, mental health, AA/NA) may be arranged through community support programs and agencies.

Community Corrections Center-Lincoln is a Ventures In Partnership (VIP) participant with Roper Elementary School located a short distance northeast of the Corrections Center.

The Work Release Program has been a part of Nebraska Correctional Services since 1967.

The Community Corrections Center-Omaha houses inmates who are classified at Community A or B custody levels and are near the discharge of their sentence or pending a parole hearing. Inmates on Community A are assigned to work crews where they work under the supervision of a DCS/state employee. Work Detail crews may provide services that support the facility such as food preparation, housekeeping, and general ground and building maintenance. Other crews perform community service work like maintaining state and city parks, vehicles, roads, bridges and duties for other state facilities. Room, board, and clothing are provided. The inmate is paid a daily wage. All NDCS inmates are required to save 5% of their net earning in a release savings account.

Work Release (Community B) inmates are employed in the community and earn a competitive wage. All applicable taxes on wages are paid, in addition to paying \$10.00 per day room and board fee. Educational Release inmates attend local vocation/technical schools, community colleges and universities. They may elect to perform regular work duties or accept part-time employment to pay for their room and board.

Programs: Work detail, work release, educational release, furloughs, ABE/GED, and substance abuse programming; community activities passes (e.g. recreation, shopping, religious) and other programming (i.e. family counseling, mental health, AA/NA) may be arranged through community support programs and agencies. CCC-O (originally OCC-Work Release Unit) has been a part of Correctional Services since 1971. The current facility was constructed in July of 1985.

Work Ethic Camp's program is based on a 120 to 180 day stay. Offenders must be convicted as an adult of a felony offense. They will be sentenced to successfully complete the Work Ethic Camp as a condition of intensive supervision probation. Inmates have been placed at WEC since July 2007. They are paroled following successful completion of the program.

The Philosophy of the Work Ethic Camp is that behavior and attitude that reflect positive work ethics can be learned and transferred to all areas of an individuals life.

Offenders and inmates perform on and off-site community service work. (for local and area government and non-profit entities). Their performance and behavior is evaluated daily.

Programs including: GED/ABE, short term residential substance abuse treatment, education, Life Skills, and cognitive restructuring are held 7 days a week. Because of the intense programming, for the first 30 days offenders are not allowed visits or phone calls. After 30 days visits and phone calls are limited. Offenders are allowed to possess very few personal items. ALL clothing and hygiene items will be provided or available for purchase at the facility canteen. Following their stay at the WEC, the offender will be returned to their community, and probation or parole supervision will continue.



The Office of Adult Parole Administration was established by an act of legislation in 1969 as a program under the Department of Correctional Services. Adult Parole Administration provides supervision, guidance and assistance to offenders paroled by the Board of Parole as they re-enter the community after a period of incarceration. In 2003 LB 1199 provide that Adult Parole Administration would also provide lifetime supervision of high risk sex offenders released to the community. There are adult parole offices located in Omaha, Lincoln, Norfolk, Grand Island, North Platte and Scottsbluff to provide supervision and surveillance of parolees and sex offenders across the state. Adult parole officers work closely with local law enforcement, community service providers and members of the community to enable paroled offenders and high risk sex offenders to become law-abiding, productive members of society.

Upon admission to the Nebraska Department of Corrections, the Records Office of the receiving facility (Diagnostic & Evaluation Center for men, the Nebraska Correctional Center for Women or the Nebraska Correctional Youth Facility)) creates an "institution" inmate file. This file is maintained on active status throughout the entire period of incarceration. Upon discharge, the file is transferred to the Central Records Office for permanent storage and microfilming in compliance with the Department's Records Retention Schedule.

Per Nebraska Revised Statute 83-178, the contents of the inmate file are confidential. However, limited information is a matter of public record and may be released to the public upon request. Public Information concerning inmates is also available through the Department's Web Site:<http://www.corrections.state.ne.us/>

Along with the "institution" inmate file, a Central Office Inmate file is also created in accordance with Nebraska Revised Statute 83-1,100. This file is similar to the "institution" file maintained by the institution Records Office and is also confidential in accordance with the Statutes cited herein. The Board of Parole and its staff use this file to assist in carrying out the duties of that agency. The Central Office Departmental staff also uses this file to assist them in the routine decision making functions of those positions.

Along with the "hard copy" inmate file, an automated inmate record is maintained on a computerized Correctional Tracking System (CTS). The data maintained on this computerized system also falls under the guidelines of the confidentiality statutes cited above.

INMATE CLASSIFICATION

Inmate classification is a system for identifying inmates' needs and characteristics, and matching them with the appropriate physical security, supervision and programming. This is an ongoing process utilizing all available information, and endeavoring to base decisions on objective criteria. The classification system seeks to: assign each inmate to the least restrictive environment appropriate to maintaining public confidence and safety; facilitate the timely movement of inmates through the correctional system; provide for the assignment, continuation, and removal of inmates from Administrative Segregation status; identify inmate needs and recommend program involvement to meet those needs; and assure the most difficult classification decisions are made at the highest level of authority within the Department.

PROGRAMS ADMINISTRATOR

EDUCATION

The Department implemented a self operating special purpose school district effective January, 2008. This has been a successful transition from the previous educational provider, Metropolitan Community College. All educational programming is provided by NDCS. Instruction is made available to inmates at a time when the majority can take advantage of the programs and, whenever possible, are designed to allow inmates to enter at any time and to proceed at a self-paced rate.

Education services are typically delivered through a Learning Center which is staffed by teachers who are certified by the Nebraska Department of Education. Educational staff work together as a team to provide an integrated program of educational offerings and services designed to provide individual inmates those specific educational opportunities most used and relevant to their futures. These options include assessment, literacy instruction, English as a Second Language (ESL), Adult Basic/Education/General Education Development (ABE/GED) and life skills/pre-release courses. Offerings are delivered in a variety of formats including traditional classroom lecture/discussion, individualized computer-assisted learning, individualized tutoring. The Test of Adult Basic Education (TABE) is used to test achievement levels of inmates upon entry into the ABE/GED program, enabling staff to provide appropriate placement, and periodically on an individual basis to assess progress. The BEST test is used to assess ESL students

INTERSTATE CORRECTIONS COMPACT

Under the provisions of the Interstate Corrections Compact, the Nebraska Department of Correctional Services has entered into agreements with forty (40) other states.

This provides Nebraska inmates the opportunity to request to serve their Nebraska sentence in one of those states. Reciprocal inmates from other states may then be accepted in return.

Interstate transfers may be approved for a number of reasons, but are generally arranged to enable an inmate to be closer to family and maintain family ties. As of June 30, 2007, there were 23 Nebraska inmates serving their sentences in other states, and 22 inmates from other states serving their sentences in Nebraska.

SELF-BETTERMENT GROUPS

Opportunities for self-betterment are available to inmates, but vary depending upon the institution. Clubs, support groups, and cultural awareness organizations include: Sertoma, Toastmasters, Stamp Club, Veterans, Alcoholics Anonymous, Narcotics Anonymous, 7th Step (a release preparation group), Harambee (African Americans), Mexican Awareness Through Association (MATA), and Native American Spiritual and Cultural Association (NASCA).

VOLUNTEER SERVICES

Volunteers assist in providing a variety of services to inmates through clubs, education, religious activities, and self-betterment groups. Additionally, a large number of inmates' family members and friends offer their time sponsoring inmates on furloughs and passes into the community.

LIBRARY SERVICES

The Department of Corrections maintains eight correctional libraries. Library services are available to all inmates and assist in meeting their educational, recreational and therapeutic needs. Inmates may request books and other resources from the interlibrary loan program. Additionally, computer reference centers are available as well as online or CD-Rom based legal resources. The Department of Corrections maintains eight correctional libraries, which includes the addition of the new law library at the Work Ethic Camp.

To ensure compliance, law library services provide inmate access to the courts. Services are available on a daily basis, including evenings and weekends.

RELIGIOUS SERVICES

Joe Baldassano 402-479-5730

The Department provides opportunities for inmates to practice their religious faith. Maintaining impartiality, consistency and equality for time, space, and resources among all recognized faith groups is a prime consideration. Each institution assigns a person to coordinate religious activities. Guidance for the implementation of the agency religious program is obtained through the Religion Study Committee (RSC). The assistant to the Deputy Director for institutions is the coordinator for the agency's religious program at the Central Office level, and co-chairs the Religion Study Committee. The Religion Study Committee membership is comprised of the facility religious coordinators and a legal Representative.

NDCS Programs and Community Services

Reentry Program

NDCS has applied for and received a grant of \$2,070,000 from the U.S. Department of Justice, Office of Justice Programs, to establish a Reentry Program that can be sustained and replicated throughout Nebraska after the grant expired December 31, 2007. The grant stipulates that a specific geographic location be identified in the state as the initial focal point for this initiative. The grant further stipulates that inmates participating be serious and violent offenders who are at high risk to recidivate and between the ages of 19 and 65 years. Utilizing a comprehensive form of case management, NDCS is focusing specifically on issues including substance abuse, mental health, housing, employment, education, mentoring, transportation, criminal thinking, and parenting/family reunification needs. We also partner with community-based service providers including the Health and Human Services System, the Department of Labor, Department of Housing and Urban Development, along with faith-based prison ministries and other social service entities. Successful reintegration of offenders back into society is our objective. NDCS believes that forging a partnership between the community and the correctional system will best serve the interest of all Nebraskans.

Currently, NDCS has served 65 high risk male and female inmates.

INMATE RISK & NEEDS ASSESSMENTS

Currently the Nebraska Department of Correctional Services utilizes four Risk & Needs Assessment instruments.

Institutional Community	identifies appropriate inmates for the Reentry Program, provides information to the Parole Board for consideration prior to being places on parole.
Community re-assessments	provides information to Adult Parole Administration while an inmates is participating on parole.
Aggression / Vulnerable	identifies inmates who may be a risk to other inmates or staff and those inmates who may be at risk from other inmates.

These assessment instruments are valuable in aiding staff in appropriate identification for program and parole participation, institutional security risk and discharge planning.

The Special Services Unit was established in 1983. At that time primary duties were to return Parole Absconders and Escapees to the institution. Over the years the duties have expanded to include Detainers, Warrants of Arrest, Prisoner Transportation, Inmate Calling System, Teletype Services, Acquisition of Security Equipment, Radio Communication Licensing, and administrative support for the Governor's Office in association with formal extradition proceedings.

TRANSPORTATION

The Transportation Unit employs two Warrant and Extradition Officers who work closely with local, state and federal agencies. Their duties include the return of Escapees, Parole Absconders and Parole Violators, Interstate Transfers of Inmates, Institutional Transfers, Transporting Parolees for Revocation Hearings, Waivers of Extradition, and notification of inmate release dates to agencies who have lodged detainers.

In addition to the Department of Correctional Services duties, the Special Services Unit provides administrative support to the Governor's Office in reviewing and processing Governor's Warrants in the requisition of wanted fugitives.

DETAINERS/WARRANTS/TRIAL REQUESTS

The Special Services Unit supervisor serves as the central administrator acting under the supervision of the department director in implementing the Interstate Agreement on Detainers (IAD). The IAD is a compact comprising of 48 states, the District of Columbia and the United States government. It provides for the administrative transfer of prisoners who are wanted by other states for trial on criminal charges. Within the State of Nebraska, the disposition of untried charges pending in county and local jurisdictions are handled according to procedures similar to those contained in the IAD. The purpose of the IAD and the intrastate Disposition of Untried Charges is to provide a process by which prisoners and prosecutors may initiate steps to resolve outstanding criminal charges upon which detainers are based. Provisions for speedy trials help to alleviate uncertainties that slow programming and rehabilitative opportunities for prisoners within the correctional system.

The Diagnostic and Evaluation Center was opened in August of 1979 as a 160-bed, maximum custody, reception, diagnostic, evaluation, assessment, classification and assignment facility.

The single structure, two-story institution consists of nine inmate housing units and an infirmary, which includes eight licensed hospital beds and a fully staffed initial admission clinic. Administrative offices and the infirmary are located on the upper level of the institution. All other inmate housing, programming areas, a gymnasium and custody and case management offices, are located on the lower level.

As provided by State Statute, all adult males sentenced to the Department of Correctional Services by the County and District courts of the State of Nebraska are received into the correctional system at the Diagnostic and Evaluation Center. In addition, the institution houses ninety-day evaluators sentenced by the court for assessment, county safekeepers, interstate transfers, returned parolees and escapees.

Programs: Due to the short length of stay at the institution, there are no industry programs and limited programming.

Each newly admitted inmate, following review of the admission order to ensure legal commitment, begins participation in an intensive medical, psychological and social assessment process. This process culminates in the finalization of an individual classification study and specific programming recommendations to the Classification Officer relative to custody status and institutional placement. Varied program services are offered and encouraged through recreation and library programs. The maintenance of family and community ties is encouraged through the visitation, mail and telephone programs. Religious programming is also available to the inmate population. Other opportunities including Alcoholics Anonymous, and a Pre-Release program are available for inmate participation. The Diagnostic and Evaluation Center has been a part of Nebraska Correctional Services since 1979.

The Nebraska Department of Correctional Services' Lincoln Correction Center, located in the capital city of Lincoln, is a medium/maximum security facility for adult male offenders. Originally opened as part of the adjacent maximum security Diagnostic and Evaluation center in 1979, the two units were separated into two distinct facilities in 1993. Due to their close proximity, the Diagnostic and Evaluation Center continues to provide after hours medical coverage for Lincoln Correction Center.

Lincoln Correction Center provides care, custody and programming services to a variety of primarily younger, first time inmates. Each housing unit is unique. One complete unit serves the socially and developmentally impaired inmates and contains an inpatient program for sex offenders. Two units are designed as segregation units. Three-quarters of one unit is designed to house inmates who have been classified to protective custody status. The remaining housing units house general population inmates. All inmates are provided the opportunity to become involved in academic programs. All general population inmates may participate in academic, institutional maintenance and work programs.

Structure, philosophy and dedicated personnel facilitate cooperation between security staff and other departments. The institution provides a unit management program approach that is responsive to the needs of the inmate population while maintaining a secure environment. Inmate supervision is a responsibility shared by staff at all levels in all departments.

The Nebraska Correctional Center for Women is the only secure state correctional institution for adult women. NCCW began operation in 1920 as the "State Reformatory for Women". The original facility consisted of a two-story house used as an inmate and staff residence. The institution was a working dairy farm. The current institution consists of 17 buildings on 27 acres of land secured by two security fences. A 12.5 million dollar addition to the facility was opened in October 2004. The original house, known as the Cottage is still being used today as a learning center for the Living Skills Program. NCCW is the Diagnostic and Evaluation center for all females committed to the State Department of Corrections.

Parenting Program: Started in 1974, the Parenting Program at NCCW was the first of its kind in the United States, allowing overnight visits for children.

In 1994, NCCW implemented another cutting edge mother/child program, a Nursery modeled after the Bedford Hills Correctional Center in New York, the Nursery Program allows mothers to keep their infant child with them on grounds for up to 18 months, with the goal of having mother and child leave together.

Both parenting programs include classes and workshops on parenting skills, prenatal care, child development, child health and safety, and improving relationships. Inmates who participate in the Parenting Programs must meet all NCCW eligibility requirements prior to visits or admittance into the Nursery Program.

Programs: In-Patient Substance Abuse Program, Out-Patient Substance Abuse, Outpatient Mental Health Programs, General Education (has a state accredited ABE program), Prison Industries Employment and college level classes.

The Nebraska Correctional Youth Facility (NCYF) came into existence in 1994 with Legislative Bill 988, which created the Office of Juvenile Services and established the requirement to plan for the construction of a Secure Youth Confinement Facility. Subsequently, the facility was transferred to the Nebraska Department of Correctional Services. The NCYF received its first inmates in August 1998. NCYF serves as the reception center for youthful male inmates who are 18 years of age and under with the Nebraska Department of Correctional Services. NCYF houses inmates from early adolescence to age 21 years 10 months. The inmates are introduced to NCYF through its Orientation Program. This 30-day program consists of a functional overview of each department prior to initial classification and appropriate placement to general population. Unit Management, Custody, Mental Health, Substance Abuse and Education focus on the team approach to coordinate programming at NCYF. NCYF inmates experience a highly structured facility that emphasizes the ability to transition back into society. Volunteers from the community provide invaluable support for continuation and expansion of the various programs at NCYF.

Programs:

ABE/GED/Basic Literacy; college courses; English as a Second Language; Pre-Release; Parenting Skills; Work Attitudes and Behaviors; Substance Abuse Treatment/ Out-Patient Programming to include Individual Counseling, Alcohol and Drug Education/ Prevention, 12-Step, and Relapse Prevention; Mental Health Programming for Socially and Developmentally Impaired Inmates, to include individual counseling services, group psychotherapy services, Anger Management, Victim Impact Class, Cognitive Thinking; and vocational programs such as Food Service, Project Greenthumb, and Project H.E.A.R.T. (Humane Education for At Risk Teens), a joint program between the Nebraska Correctional Youth Facility and the Nebraska Humane Society.



The Nebraska State Penitentiary located in Lincoln is the oldest state correctional facility in Nebraska, opening in 1869. Until after World War I, it was the only adult correctional facility in the state.

During 1980-1981, the existing cellblocks constructed during the second half of the 19th century were replaced by four (later five) modular housing units. A new administrative complex and an EPA approved multi-fuel power plant were also completed at the same time. An existing dormitory building constructed in the 1950's was retained as a medium security facility and a portion currently houses the Residential Treatment Community for substance abuse offenders. Two new 100 bed dormitory units were opened in 1998. A thirty-six-bed control unit also built in the 1950's continues in use as a high security segregation facility. The Industries Plant, Laundry and other support buildings were retained from the older facility as well.

The inmate population at the NSP typically consists of 21 years of age and older inmates serving medium to longer sentences.

The Nebraska State Penitentiary uses the Unit Management concept designed to improve control and staff/inmate relationships by dividing the larger institution population into smaller, more manageable groups and to improve and personalize the delivery of rehabilitative services.

NSP is the site of major components of the Agency's Cornhusker State Industries (CSI) program.

Programs: NSP offers a variety of education/rehabilitation programs designed to enhance an inmate's chances for successful community adjustment upon release. These include Educational/Life Skills and Vocational Programs, Self-Improvement (Residential and Outpatient Substance Abuse Treatment, Religious Programming and Self-Betterment Activities), and Support Services. The Nebraska State Penitentiary has been a part of Nebraska Correctional Services since 1869.

OCC was opened April 24, 1984, at a total cost of approximately \$17 million. The facility has current population of approximately 600 adult male inmates.

The center has a separate entrance/Administration building as well as an inner complex including four housing units, an indoor/outdoor visiting area, library, chapel, dental and medical area, segregation unit, academic and pre-employment training areas, central physical plant, laundry, kitchen and dining room, Cornhusker State Industries, a canteen and gymnasium.



The Tecumseh State Correctional Institution (TSCI) was established by LB 150 in 1997 and is the only Nebraska Maximum/Medium Custody, adult male facility in a rural setting.

All inmates at the Tecumseh State Correctional Institution are males adjudicated as adults and classified as medium or maximum custody. (Approximately 30 Minimum Custody inmates are housed at TSCI for outside grounds, administration building and warehouse jobs.) The institution has a design capacity for 960 inmates, which includes 768 general population beds and a 192-bed special management unit for Administrative Segregation, Disciplinary Segregation and Intensive Management inmates. Death Row inmates are housed at TSCI but the death penalty will continue to be administered at the Nebraska State Penitentiary in Lincoln.

Educational Programming

The Nebraska Department of Correctional Services offers educational programming at each correctional site based on the specific need of the population and availability of space at that site.

The general rule for teacher/student ratio is one teacher for every fifteen students. Most sites offer Job Skills, Parenting, Life Skills, General Education, Adult Basic Education, English as a second language and correspondence study.

RELIGIOUS SERVICES

The Department provides opportunities for inmates to practice their religious faith. Maintaining impartiality, consistency and equality for time, space, and resources among all recognized faith groups is a prime consideration. Each institution assigns a person to coordinate religious activities. Guidance for the implementation of the agency religious program is obtained through the Religion Study Committee (RSC). The assistant to the Deputy Director for institutions is the coordinator for the agency's religious program at the Central Office level, and co-chairs the Religion Study Committee. The Religion Study Committee membership is comprised of the facility religious coordinators and a legal Representative.

INTERPRETATION/TRANSLATION SERVICES

In 1998, LB 389 appropriated funding to the Department of Correctional Services for four full-time interpreters. Four Spanish and English speaking interpreters were hired to help facilitate oral and written interpretation and translation services to inmates, inmate families and the community regarding matters relative to the Department of Correctional Services. These staff are assigned by geographic area and travel to each DCS institution/program as needed. The Department's interpreters also make arrangements with community resources, for interpretation and translation services for languages other than Spanish and English.

EMERGENCY PREPAREDNESS

Emergency Preparedness is a comprehensive system that requires a continuous commitment to personnel and resources to ensure a systematic approach to responding to emergencies. Key to the success of the Emergency Preparedness Program are the full time staff at the Department level as well as the facility level that ensure the Department's readiness to respond through emergency policy, planning, training, check lists and exercises. Essential to the success of a response to a facility emergency are the specially trained teams. The teams consist of two Department wide teams—Special Operations Response Team (SORT) and the Crisis Negotiation Team (CNT) and the institutional based Correctional Emergency Response Team (CERT).

INVESTIGATIONS

The Department Investigation program is committed to the investigation and prosecution of all criminal activity by either staff or inmates. The Department has two full time investigators that are law enforcement certified and have the power to arrest and detain. The Department Investigators work closely with the facility staff in developing information and they also work closely with outside agencies, i.e., the Nebraska State Patrol, local law enforcement and County Attorneys.

DRUG INTERDICTION

The Department has a zero tolerance policy on the use of drugs by inmates and staff. The Drug Interdiction program works toward that goal by employing a multi-faceted approach. The program consists of information gathering and sharing, telephone monitoring, random and targeted urinalysis testing on staff and inmates, ION Mobility Spectrometry searches of visitors, staff and inmates, K-9 searches and the Drug Offender Classification Program. Note that the Planning and Research division keeps information and data regarding the Department's drug interdiction efforts. Additionally, that section coordinates with lab personnel and generates the lists of inmates to be tested. Please refer to the section in the Annual Report under Drug Testing/Drug Intelligence for further information.

LEISURE TIME ACTIVITIES



These include exercise, athletics, games, music, painting, writing, and handcrafts.

NDCS SECURITY MANUAL

The Department's Security Manual contains procedures for institution security and control, with detailed instructions for implementing these procedures. The Department Security Administrators as well as the Department Emergency Management Supervisor, the Planning, Research and Accreditation Manager, the Deputy Directors and the Director review all Security Manual Chapters and Audit Instruments annually. The office of the Deputy Director – Institutions is responsible for updating and maintaining the Security Manual. Additionally, the office of the Deputy Director – Institutions works with the Security Administrators in reviewing the Department's policy directives in order to determine whether immediate revisions to the Security Manual are required. Security Audit Teams conduct security audits of each facility on an annual basis. Along with security audits, security procedure assessments are conducted at each NDCS facility three to four times per year. The office of the Deputy Director – Institutions is responsible for reviewing audit and procedure assessment reports and following up as necessary. Additionally, this office maintains records of security audits and procedure assessments conducted by the Department.


